The Town of Yorktown Planning Board will not be meeting in person. In accordance with the Governor's Executive Order 202.1, until further notice, meetings will be held via video conference. The Town will continue to hold public hearings. The Town of Yorktown has organized an interactive Planning Board meeting for 7:00 pm on Monday, April 27, 2020. This meeting will be broadcast Live on the town cable channels; Optimum channel 20 and Verizon FiOS channel 33. In addition, the public will have an opportunity to participate in the meeting by joining the Zoom video conference by following the instructions below. If you have a computer, tablet, or smartphone, you will be able to see and hear the meeting while it is occurring. We will also have a dial-in number for you to call if you are watching the meeting on Television, don't have a computer, or have problems with your device's audio.
