

## NOTICE TO INTERESTED PARTIES

NOTICE IS HEREBY GIVEN that a public hearing will be reconvened by the Town Board of the Town of Yorktown, Westchester County, New York, at Lakeside at Osceola (a/k/a Osceola Beach), 399 East Main Street, Jefferson Valley, NY 10535 on Tuesday, July 7, 2009 at 6:30 p.m. or as soon thereafter as the same can be heard. (In the event of inclement weather, the public hearing will be held in the Yorktown Town Hall Board Room, 363 Underhill Avenue, Yorktown Heights, NY 10598, at the same date and time. A message will be posted on the Town's website, [www.yorktownny.org](http://www.yorktownny.org), on July 7, 2009 indicating if the venue will be moved to 363 Underhill Avenue due to inclement weather.) The public hearing will be reconvened for the public to comment orally and/or in writing upon the proposed local law described below.
