TOWN BOARD MEETING

Supervisor Michael J. Grace called the meeting to order.

EXECUTIVE SESSION

Upon motion made by Councilman Lachterman, seconded by Councilman Patel, the Town Board moved into Executive Session to discuss the employment of a particular individual.

Upon motion made by Supervisor Grace, seconded by Councilman Bernard, the Town Board moved out of Executive Session and proceeded with the meeting.

MORRIS LANE- STORMWATER POLLUTION PREVENTION PLAN

Mr. Phil Sanders was present to request a Stormwater Pollution Prevention Plan for property on Morris Lane. He explained that the current plan exceeds the threshold of fill to be removed from the site.

Town Engineer Michael Quinn suggested the applicant come in and have a meeting with him to see if some of the concerns about this site plan can be addressed. One of the issues is that the driveway is very steep. The applicant agreed that he would come in for a meeting.

BOCES WATER USAGE

Water Distribution Superintendent David Rambo stated that the Water Department discovered that there was no meter or backflow devices attached to the culinary school building located on the BOCES campus in 2011. There is an estimated water usage bill of approximately \$25,000. Superintendent Rambo stated that he contacted BOCES and they are willing to pay half the estimated amount. The Town Attorney will send a letter to BOCES regarding this issue.

LITTERING

Town Attorney Michael McDermott suggested the Town Board adopt a local law establishing something similar to a "Red Light Camera Law." The law would allow for the owner of the vehicle caught on the camera to be issued a fine for littering rather than the driver of the vehicle.

Kim Angliss gage, Coordinator, Refuse and Recycling Department stated that the Battle of Yorktown was a great success but the Town needs more attention to littering around Town. She would like the Town Board to approve her purchasing "Do Not Litter Signs" which she would like to place in certain high litter areas around Town.

Supervisor Grace stated that this legislation would be the first of its kind in the nation to be passed by a local municipality.

Councilman Diana asked the Town Attorney to check the New York State Vehicle and Traffic Law with regards to littering on roadways to see if there is a law already in place.

Supervisor Grace would like to coordinate both the local law and the new signs to promote a Do Not Litter campaign around the Town.

DUMPSTER ENCLOURE PROPOSED LOCAL LAW

Town Attorney Michael McDermott stated that he prepared a draft local law for the Town Board to consider with regards to amending Chapter 245-5 of the Code of the Town of Yorktown entitled "SOLID WASTE". This would regulate dumpster enclosures, screening and fencing around receptacles and compactors.
