TOWN BOARD MEETING

Supervisor Matthew Slater called the meeting to order.

EXECUTIVE SESSION

Upon motion made by Councilman Esposito, seconded by Councilwoman Haughwout, the Town Board moved into Executive Session to discuss Police Department personnel issues regarding individual employees, as well as litigation and negotiations. Upon motion made by Councilman Lachterman, seconded by Councilman Diana, the Town Board moved out of Executive Session and proceeded with the meeting.

PLEDGE OF ALLEGIANCE

Supervisor Slater led the Pledge of Allegiance.

MOMENT OF SILENCE

Supervisor Slater asked for a moment of silence to remember our first responders. He said that it is Military Appreciation Month and asked to remember all of those serving to protect our freedoms. Supervisor Slater asked to remember teachers, as today is Teacher Appreciation Day. He also asked that we keep in our thoughts and prayers Yonkers Police Detective Brian Menton who left the hospital today after being wounded on the job. He wished him a speedy recovery.

INTRODUCTIONS

Town Board members introduced themselves, as well as Town Clerk Diana Quast, and Town Attorney Adam Rodriguez.

REPORT FROM THE TOWN SUPERVISOR

Supervisor Slater reported on recent Town events and updates, including the following:

- Expansion of the School Resource Officer program with Yorktown Central School District that will add an eighth resource officer based at the Crompond Elementary School (also covering Mohansic Elementary and Brookside Elementary)
- The Town will be entering into a lease agreement with the Yorktown Central School District to lease the Downing Park Commuter Lot. A permit system will be instituted for students parking there.
- ARPA community survey is still open for residents to assist in deciding where ARPA money will be allocated.
- Pool openings
- Spring hydrant flushing program and Water Department updates
- The library system was the victim of a ransomware attack; however, no patron information was hacked.
- Recognition of various organization and individuals

REPORTS FROM TOWN COUNCIL

Members of the Town Council reported on recent Town events and public service announcements.

Upon motion made Councilman Lachterman, seconded by Councilman Diana,

WHEREAS, May is recognized as Mental Health Awareness Month; and

WHEREAS, mental illness is defined as a medical condition that disrupts a person's thinking, feeling, mood, ability to relate to others and daily functioning and can affect persons of any age, race, religion or socioeconomic status; and

WHEREAS, statistics show that one in four American adults experiences an episode of mental illness each year and it is estimated four million children and adolescents in America suffer from a serious mental disorder; and

WHEREAS, with treatment, recovery from serious mental illness is not only possible but probable; and

WHEREAS, the Town of Yorktown is proud to work with advocacy organizations such as NAMI of Westchester to break down the barriers, stigma and fear of discrimination that keep many from seeking help through available mental health services; and

WHEREAS, good mental health as promoted by local organizations such as the Alliance for Safe Kids is critical to the well-being of our families, communities, schools and businesses; and

WHEREAS, early intervention has proven to enhance learning, communication, social skills and underlying brain development; NOW, THEREFORE;

BE IT RESOLVED, the Town of Yorktown recognizes and celebrates May as Mental Health

Awareness Month; and

BE IT FURTHER RESOLVED, the Town of Yorktown urges all members of our communities, businesses and civic organizations to assist in increasing awareness and understanding of mental illnesses; and

BE IT FURTHER RESOLVED, the Town of Yorktown recommits to enhancing local services that further assist our residents achieve recovery from mental illness.

WHEREAS, about every two and a half minutes, a person in the U.S. is diagnosed with lung cancer; and

WHEREAS, lung cancer is the leading cause of cancer deaths for women and men; and

WHEREAS, lung cancer screening saves lives, and advocacy and increased awareness will result in more high-risk individuals getting screened.

WHEREAS, public support for research funding will result in new treatments and better methods of early detection; and

WHEREAS, LUNG FORCE is a national initiative led by the American Lung Association, to defeat lung cancer.

BE IT RESOLVED, that the Town of Yorktown hereby designates the second week in May as Turquoise Takeover Week throughout the Town of Yorktown and encourages all residents of the Town of Yorktown to learn more about lung cancer, risk factors and early detection.

MY BROTHER VINNY

Paula Miritello and Kenny Beck, members of the organization My Brother Vinny, came before the Board to do a presentation of the work they do with veterans. Ms. Miritello said that the organization was named after her brother, who died at the age of 20 from cerebral palsy complications. In order to keep his name alive, Ms. Miritello began doing charity work that eventually led to assisting veterans. She explained the plight of homeless veterans. Her work is to assist these veterans setting up their homes for which they receive government vouchers. My Brother Vinny relies on donations from the public. Ms. Miritello mentioned some of the types of donations they accept and welcome volunteers. She said that their website has a wish list of items or services they need. The Town Board commended Ms. Miritello on the excellent and important work My Brother Vinny does and congratulated her on their recent win of the Vetty Award (their third) that is presented by the Academy of United States Veterans.

POET LAUREATE

John McMullen, Poet Laureate, read an original poem, "The Mind March."

COURTESY OF THE FLOOR

The following members of the public spoke:

- Susan Siegel, resident, asked questions about items on the agenda. She questioned the resolution for budget transfer for Yorktown Sewer of \$226,000 (the budget for this was \$115,000) and another was budgeted for \$50,000 and it is now \$161,000. She asked if there was an unexpected repair that has to be done and is one or both of the transfers reimbursable by DEP. She asked about the rebid for the cement relining project and options under the first bid that was done a long time ago. She said that she thought the first bid would hold.
- Dan Strauss, resident, spoke about illegal signage in Yorktown. He said that all signs (legal

and illegal) are, as far as he is concerned, a blight on the Town, as well as an ecological blight because most of them wind up on the ground. He said he has been trying to address this issue for six years.

- Sarah Wilson, resident, mentioned two upcoming events: May 5 will be the last of a series on climate change sponsored by Yorktown 100 at the library, and The Garden of Hope event at Willow Park on Saturday, 11AM-4PM.

Upon motion made by Councilman Lachterman, seconded by Councilman Diana, Courtesy of the Floor was closed.

Supervisor Slater responded to Ms. Siegel's questions regarding the budget transfers. He said that the \$161,000 is reimbursable by the DEP. He said that there are issues with the UV channels and additional parts are needed, as well as supply chain issues and material costs have increased the costs. He said that they did reach out to the vendor from the first cement relining bid and were told that because of the same issues (supply chain issues, material costs) they could not honor the original bid price, causing the Town to reject and rebid.

Supervisor Slater said he would contact the Code Enforcement Officer to take down the illegal signs that Mr. Strauss was referring to in his earlier comments. He spoke about a potential registry for signage to track where signs are going and the removal of them.

ADOPTION OF LOCAL LAW NO. 5 OF 2022 AMENDING CHAPTER 300-81.4 ENTITLED "SOLAR POWER GENERATION SYSTEMS AND FACILITIES" RESOLUTION #212

Upon motion made by Councilman Diana, seconded by Councilman Esposito,

NOW, THEREFORE, BE IT RESOLVED that Local Law No. 5 of 2022, as amended and annexed hereto, be and is hereby adopted.

Local Law No. 5 of 2021 was thereupon declared adopted.

CONVENE A PUBLIC HEARING TO CONSIDER A PROPOSED LOCAL LAW AMENDING CHAPTER 300 ENTITLED "ZONING," BY ADDING A NEW SECTION 300-82 ENTITLED "FARMLAND SPECIAL EVENTS."

Supervisor Matthew Slater convened a public hearing to consider a Proposed Local Law amending Chapter 300 of the Code of the Town of Yorktown entitled "ZONING," Article VII, entitled "Permitted Special Uses" by adding a new section 300-82 entitled "Farmland Special Events."

Town Clerk Diana Quast display the Affidavit of Publication for the public hearing.

Supervisor Slater said that this was a discussion at a previous work session with some people who came to the Board interested in utilizing farms as wedding venues. He said that the Board seemed amenable to that being a good use for those properties to help expand their businesses and draw visitors to the area. Supervisor Slater introduced Director of Planning John Tegeder.

Mr. Tegeder said that this proposed amendment would enable a special permit for farms to conduct special events (i.e., weddings) on the farm property and would require that they comport with the requirement of the farm special permit and would require a map and a parking plan and other necessary information for the Zoning Board to consider granting the permit.

The Town Board discussed the popularity of holding special events on farms. Supervisor Slater said two responses were received as a result of the referral that was sent: Westchester County Planning who determined this issue was a local matter to be decided by the local town board, and one from the Planning Board. The Planning Board suggested refining the definition of "special events" to clarify what the permitted events are in order to hold an event. They recommended the Town Board to consider the impacts of traffic, noise, and sanitary waste to the subject property and surrounding neighborhood. He said that they generally supported the idea. Supervisor Slater asked Mr. Tegeder how the Town could or should legislate the second point the Planning Board made regarding traffic, noise, and sanitary waste. He asked if these should be parameters by which they would be considered for approval.

Mr. Tegeder said that it would be. He said that it is always a “fail-safe” situation if there is guidance in the law for the Planning Board to follow. Supervisor Slater suggested that it be stipulated in the Code to require sanitary waste facilities be made available.

The Town Board members discussed with Mr. Tegeder the different scenarios that could result from events and the need to be explicit in the law.

The following members of the public spoke:

- Susan Siegel, resident, said she supports the idea of farms being able to hold events. She questioned the permit being issued for three years since the events could all be different (weddings, concerts, craft fairs, etc.). She said that each type of event may have very different needs. The Town Board agreed.

Councilwoman Haughwout said the three-year permit would be for the farm and each event would have its own regulations to follow. Town Attorney Adam Rodriguez said events would have to comply with whatever restrictions are placed on the special permit by the Zoning Board.

- Ms. Siegel said she felt that since most of the issues would be site plan-related, the Planning Board would be better suited to overseeing these permits than the Zoning Board.
- Tom Deacon, a resident and who also runs Fable Farm in Yorktown, said that he very much appreciated the support of the Board for small family farms and for working to decrease regulatory hurdles. He said that he had many questions after reviewing the proposed legislations. He suggested a joint meeting be held between the Town and small farm owners in the area to understand the benefits and the consequences. He expressed his support but also deep concerns about the farmland special event zoning change. Mr. Deacon said that a zoning change could create an extra source of income for struggling farms and operations like his, but could also have unintended consequences. He mentioned some of his concerns (organic farming, excavation, generators, etc.). He said an unintended consequence would be shifting farmland into more of a non-farm commercial enterprise.
- Jay Kopstein, resident, pointed out that Section 300-3 of the Town Code defines a farm and all you would have to do is reference back to the definition that already exists in order to answer questions that have come up about definition.
- Sarah Wilson, resident, said that it would make sense to keep the public hearing open and the Board said that they did not have an intention to close this hearing, as there is much more to be discussed.

All those present having been given the opportunity to be heard and there being no further discussion, Upon motion made by Councilman Esposito, seconded by Councilman Diana, the public hearing was adjourned.

AUTHORIZE TOWN CLERK TO ADVERTISE A PUBLIC HEARING TO CONSIDER AMENDING CHAPTER 275 ENTITLED, “VEHICLES AND TRAFFIC” SECTION 275-4 AND 275-6
RESOLUTION #213

Upon motion made by Councilman Diana, seconded by Councilman Esposito,

NOTICE IS HEREBY GIVEN that a public hearing will be held by the Town Board, Town of Yorktown, Westchester County, New York, at the Town Hall, 363 Underhill Avenue, Yorktown Heights, New York 10598 on May 17, 2022, at 7:30 o'clock PM, or as soon thereafter as the same can be heard, to consider amending Chapter 275 of the Code of the Town of Yorktown entitled “VEHICLES AND TRAFFIC,” Section 275-4(A) adding the following no parking areas:

- Rochambeau Drive, west side, from Underhill Avenue to the end of the road
- Gomer Street, both sides, from Granite Springs Road to the intersection with Marlet Place
- Scofield Road, south side, from its intersection with Mohegan Avenue to a point 100 feet east of its intersection with Mohegan Avenue

The following proposed full stop locations will also be considered to amend Section 275-6(A) of the Code of the Town of Yorktown:

- Poplar Street At the intersection with Forest Court (both directions)
- Forest Court At the intersection with Poplar Street
- Suncrest Avenue At the intersection with Robin Road (both directions)
- Robin Road At the intersection with Suncrest Avenue
- Bunney Lane At the intersection with Pine Grove Court
- Pine Grove Court At the intersection with Bunney Lane (both directions)
- Valleyview Street In the southerly direction at the intersection with Eleanor Drive

Slater, Diana, Esposito, Haughwout, Lachterman Voting Aye
Resolution adopted.

Town Engineer Dan Ciarcia said that there was a big lag between actually having the hearing and getting funding in place and in preparing for this, errors were discovered in some of the parcel information and calling for another public hearing is really just a matter of housekeeping. He said that the number of parcels is now approximately 300. He also spoke of plans to do an informational hearing to bring residents up to speed.

APPROVE ORDER CALLING A PUBLIC HEARING ON ESTABLISHMENT OF A PROPOSED HALLOCKS MILL SEWER DISTRICT EXTENSION IN THE TOWN OF YORKTOWN RESOLUTION #214

Upon motion made by Councilman Diana, seconded by Councilman Lachterman,

WHEREAS, the Town Board of the Town of Yorktown, Westchester County, New York, has received a petition, together with a map showing the boundaries of a proposed sewer district extension in said Town, to be known as Hallocks Mill Sewer District Extension in the Town of Yorktown (the “Extension”) a general plan to serve said Extension, and a report of the proposed method of operation thereof; and

WHEREAS, said map, plan and report were prepared by a competent engineer duly licensed by the State of New York, and have been filed in the office of the Town Clerk of said Town, where the same are available during regular office hours for examination by any persons interested in the subject matter thereof, including estimate of cost; and

WHEREAS, the boundaries of said Extension have been finalized and shall be as described in Exhibit A attached hereto and hereby incorporated herein; and

WHEREAS, the improvements proposed consist of the construction of a sanitary sewer system at a maximum estimated cost of \$14,300,000; and

WHEREAS, the cost of hook-up fees to the typical property in said Extension is \$5,850; and

WHEREAS, the estimated cost of said Extension to the typical property therein is \$1,494 in the first year in which operation, maintenance, debt service and other charges and expenses are to be paid (\$782 for a typical property not connected); and

WHEREAS, a detailed explanation of the manner by which such costs were computed has been filed in the office of the Town Clerk where the same are available during regular office hours for examination by any person interested in the subject matter thereof; and

WHEREAS, it is now desired to call a public hearing upon the question of the establishment of said Extension and the improvements proposed therefor, all pursuant to Section 193 of the Town Law;

NOW, THEREFORE, BE IT ORDERED, by the Town Board of the Town of Yorktown, Westchester County, New York, as follows:

Section 1. A meeting of the Town Board of the Town of Yorktown, Westchester County, New York, shall be held at the Town Hall, 363 Underhill Avenue, in Yorktown Heights, New York, in said Town, on the 24th day of May, 2022, at 7:30 o'clock P.M., Prevailing Time, for the purpose of holding a public hearing to consider the establishment of the Sewer District Extension in said Town as described in the preambles hereof, to be known as Hallocks Mill Sewer District Extension, and the improvements proposed therefor, and to consider the petition, map, plan and report filed in

relation thereto, and to hear all persons interested in the subject matter thereof concerning the same, and for such other action on the part of said Town Board as may be required by law or shall be proper in the premises.

Section 2. The Town Clerk is hereby authorized and directed to cause a copy of this order to be published once in the official newspaper of said Town, the first publication thereof to be not less than ten nor more than twenty days before the day set herein for the hearing as aforesaid, and said Town Clerk shall also cause a copy thereof to be posted on the sign-board of the Town maintained pursuant to subdivision 6 of Section 30 of the Town Law not less than ten nor more than twenty days before the day set for the hearing as aforesaid.
